

## **EZ COLOR TRADING TERMS OF SERVICE AGREEMENT**

THIS **TERMS OF SERVICE AGREEMENT** ("Agreement") is made between EZ Color Trading ("System Provider") and any person ("User") who installs the Software and/or completes the registration process to subscribe to EZ Color Trading ("Software/Service").

**BY COMPLETING THE PAYPAL PAYMENT PROCESS OR ACCESSING, USING OR INSTALLING ANY PART OF THE SOFTWARE/SERVICE, USER EXPRESSLY AGREES TO AND CONSENTS TO BE BOUND BY ALL OF THE TERMS OF THIS AGREEMENT. IF USER DOES NOT AGREE TO ALL OF THE TERMS OF THIS AGREEMENT, PLEASE PROMPTLY CANCEL THE PAYPAL TRANSACTION AND DO NOT USE OR INSTALL ANY PART OF THE SOFTWARE/SERVICE. THIS AGREEMENT IS APPLICABLE FOR ALL LEASED VERSIONS OF THE SOFTWARE/SERVICE INCLUDING, BUT NOT LIMITED TO BETA VERSIONS. THIS AGREEMENT MAY BE AMENDED FROM TIME TO TIME AT THE SOLE DISCRETION OF SYSTEM PROVIDER. SYSTEM PROVIDER SHALL PROVIDE NOTICE TO USER OF AMENDMENTS BY POSTING THE UPDATED TERMS OF SERVICE ON SERVICE PROVIDER'S WEBSITE. USER SHALL HAVE THE OPPORTUNITY TO REFUSE SAID AMENDMENTS SOLELY BY REQUESTING TERMINATION OF ACCESS TO THE SOFTWARE/SERVICE.**
